

BCA Summer Camp Conditions 2025

1) ACCEPTANCE OF CONDITIONS

- These terms define the agreement between the British College of Andorra Summer Camp (hereafter, BCA SC) and the parents of enrolled students.

2) SCHEDULE

- BCA SC activities run from **9:00 to 16:45**.
- **Drop-off:** 8:45–9:00
- **Pick-up:** 16:45–17:00
- BCA SC is not responsible for supervising students outside these hours.

3) CANTEEN

- The school canteen is **mandatory for full-time students**.
- **Snacks:** Morning snack is included for all. Children born between **2020 and 2022** also receive an afternoon snack.
- Most **allergies and food intolerances** are accommodated.

4) BUS SERVICE

- Two bus stops are available:
- **Beluga (La Illa, Escaldes):** departs 8:30 / returns 17:15
- **La Poste (Andorra la Vella):** departs 8:40 / returns 17:05
- Note:** Discounts do not apply to the bus service.

5) CANCELLATION

- All cancellations must be sent by email to summercamp@bcandorra.com.
- **Up to 16 days before** the first booked week: **100% refund**
- **15 to 5 days before:** **70% refund**
- **Less than 5 days' notice:** **no refund**.
- In case of **illness**, a **medical certificate** and at least **1 day's notice** are required for a full refund.
- Refunds are processed within **3 weeks** of cancellation.

6) IMAGE RIGHTS

- Photos are taken daily and shared privately with families via Google Drive.
- No one outside the BCA SC organization is permitted to publish photos of children who are not under their care.
- With permission, selected images may be used on the social media of **The British College of Andorra** and **Singular Acadèmia d'Anglès**.

7) PAYMENT

- Payment for the first week booked, along with 50% of any additional confirmed weeks (if more than one week is booked), must be made **via bank transfer** within 7 days of receiving the enrolment confirmation.
- Proof of payment must be sent to summercamp@bcandorra.com.
- If payment is not received within this period, BCA SC reserves the right to cancel the student's enrolment.
- Any remaining balance must be paid by June 13th, 2025, also via bank transfer.
- All payments are personal and non-transferable.

9) PERSONAL DATA

- BCA SC is co-organized by **The British College of Andorra** and **Singular Acadèmia d'Anglès**.
- All personal and administrative data will be processed in accordance with **Article 12** of the current Personal Data Protection Law.

10) INSURANCE

- All students are covered by the BCA SC's **liability and accident insurance**.
- This insurance **does not cover loss or theft** of personal belongings.
